Council, on motion by Councilmember Parks, seconded by Councilmember Polk, voted unanimously to adopt the January 14, 2014, City Council Work Session Meeting Minutes and the January 14, 2014, City Council Regular Meeting Minutes.

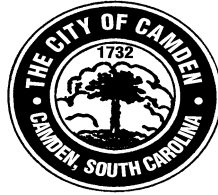

**ORDINANCE #14-001 2<sup>nd</sup> Reading**

Council, on motion by Councilmember Polk, seconded by Councilmember Parks, followed by discussion, voted unanimously to approve second reading of an Ordinance designating certain properties as Local Historic Sites. The property listed as 1707 Broad Street is hereby designated as a Historic District Property.

**ORDINANCE #14-002 2<sup>nd</sup> Reading**

Council, on motion by Councilmember Polk, seconded by Councilmember Parks, voted unanimously to approve second reading of an Ordinance consenting to an application for a cable franchise, setting franchise fees and repealing certain provisions of the Code of Ordinances.

**ORDINANCE #14-003 1<sup>st</sup> Reading**

Council, on motion by Councilmember Polk, seconded by Councilmember Parks, followed by comments from City Manager Mel Pearson and general discussion from Council, voted unanimously to approve first reading of an Ordinance amending and restating an Ordinance entitled, “An Ordinance providing for the issuance and sale of combined public utility system revenue bonds of the City of Camden, South Carolina, and other matters relating thereto,” enacted January 30, 1997; and other matters relating thereto.

**ORDINANCE #14-004 1<sup>st</sup> Reading**

Council, on motion by Councilmember Polk, seconded by Councilmember Parks, followed by comments from City Manager Mel Pearson, voted unanimously to approve first reading of an Ordinance providing for the issuance and sale of combined public utility system refunding revenue bonds to be designed Series 2014A, in the principal amount of not exceeding ten million dollars (\$10,000,000) of the City of Camden, South Carolina; and other matters relating thereto.

**ORDINANCE #14-005 1<sup>st</sup> Reading**

Council, on motion by Councilmember Parks, seconded by Councilmember Polk, followed by comments from City Manager Mel Pearson, voted unanimously to approve first reading of an Ordinance acknowledging changes to the program policies of the South Carolina Water Quality Revolving Fund Authority; approving changes to the loan agreement between the City of Camden, South Carolina and the South Carolina Water Quality Revolving Fund Authority relating to loan number 1-145-11-433-01; approving the amendment and restatement of the debt service fund and debt service reserve fund agreement relating to loan number 1-145-11-433-01; and approving the release of debt service fund moneys related to loan number 1-145-11-433-01; and other matters relating thereto.

**RESOLUTION #14-002**

Council, on motion by Councilmember Parks, seconded by Councilmember Polk, voted unanimously to approve a Resolution authorizing the Mayor to employ the City Prosecutor.
