Separate sealed BIDS for the construction of the **Ancrum Road Pump Station Upgrade** will be received by the **City of Camden at Camden City Hall Training Room**, 1000 Lyttleton Street, Camden, South Carolina, 29020 until **2 p.m.**, local time on **February 21, 2019** at which time the BIDS received will be publicly opened and read aloud.

**The Project** consists of the replacement of the existing self-priming pumps with new submersible pumps within the existing wetwell at the Ancrum Road Pump Station. Also included is the installation of a new valve vault, connection to the existing forcemain, pump control panel, all required site piping, and other related appurtenances.

Any contract or contracts awarded under this Advertisement for Bids will be funded by the City of Camden and in part by the South Carolina State Revolving Fund (SRF) administered by the South Carolina Department of Health and Environmental Control. Neither the State of South Carolina nor the United States nor any of their Departments, Agencies, or employees is or will be a party to this Advertisement for Bids or any resulting contract. The attention of the bidder is particularly called to the SRF Mandatory Supplemental General Conditions included in Appendix A of the Project Manual and the requirements summarized on the Supplement to the Bid Form. The contract will be subject to all applicable federal, state and local rules, regulations, laws, and orders. Bidders must comply with the President's Executive Order Nos. 11246 and 11375, which prohibit discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must certify that prior work they have performed is in compliance with Executive Order Nos. 11246 and 11375. Each Bidder must be qualified under the provisions of the South Carolina Contractor's Licensing Law, 1976 Code, Section 40-11-10, et seq. Furthermore, Bidders must also comply with Davis-Bacon Act and ensure that minimum wage rates are paid.

Bidders are encouraged to visit the Ancrum Road Pump Station to familiarize themselves with the project prior to bidding. For site access contact Ray Peterson at (803) 425-6045. **A Pre-Bid Conference will not be held for this project.** Engineer will transmit to all prospective Bidders of record such Addenda as Engineer considers necessary in response to questions during the bidding period. Oral statements may not be relied upon and will not be binding or legally effective.

A Bid Bond in the amount of five percent (5%) will be required. A Performance Bond and a Payment Bond, each in the amount of one hundred percent (100%) of the contract, must be furnished by the successful bidder upon award of the contract.

Copies of the Contract Documents may be obtained at the office of Design South Professionals, Inc. (herein called the Engineer), located at Three Linwa Boulevard, Anderson, South Carolina 29621, upon payment of \$150.00 (nonrefundable) for each set. In addition, a set of Contract Documents may be viewed at the office of the Engineer, Three Linwa Boulevard, Anderson, South Carolina, 29621 and the Owner at Public Works and Utilities, 1000 Lyttleton Street, Camden, South Carolina 29020. Prime contractors must purchase a complete set of plans and specifications from the official source to be considered a plan holder and to submit a bona fide bid.

The Owner reserves the right to reject any or all bids as provided in Section C-200, Instructions to Bidders, and to waive any informalities and technicalities in the bid. Any bid may be withdrawn prior to the above scheduled time for the opening of bids or authorized postponement thereof. Any bid received after the time and date specified will not be considered. No Bidder may withdraw a bid within ninety (90) days after the actual date of bid opening.
