Know all men these presents that _____ (releasor), for and in consideration of the services rendered by the City of Camden Police Department, has remised, released and forever discharged and by these presents does for him/her self, heirs, executors, administrators and successors, remise, release, acquit, satisfy and forever discharge the aid City of Camden Police Department, its agents or officers, their heirs, executors, administrators and successors of and from all, and all manner of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts agreements, promises, variances, trespasses, damages, judgments, executions, claims and demands whatsoever in law or in equity arising directly out of the acceptance of agreement to check said property, which against the City of Camden Police Department he/she ever had, now has or which his/her heirs, executors or administrators, hereafter can, shall or may have, for, upon or by reason of any matter, cause or thing whatsoever forever from the date of these presents.
