APPROVAL OF MINUTES

Council, on motion by Councilmember Graham, seconded by Mayor Pro Tem Craig, voted unanimously to adopt the regular meeting minutes of August 22, 2023.

ANNOUNCEMENTS, AWARDS, SPECIAL RECOGNITON

Council, on motion by Councilmember Smoak, seconded by Mayor Pro Tem Craig, voted unanimously to proclaim the week of September 17 through September 23, 2023 as Constitution Week and the week of September 18 through September 24, as National Diaper Need Awareness Week.
