Ted Brunson, Marietta Lake Road spoke regarding the comprehensive plan, stated it was instituted in 1996, suggest that it's a tool that needs to be followed to guide Camden being a success now and in the future.



Mike Burkett spoke of Sanders Creed Road gave brief comments regarding Camden's comprehensive plan.

Andrew Whitaker of Knights Hill road spoke regarding the 100th annual Carolina cup, 1000 acre historic property while referencing that he was against the development of the Camden Training Center.

Lynne Conto of Moultrie Road spoke regarding her concerns of the city maintaining their Horse District as specified in the Comprehensive Plan.

Kristy Ayers of Carter Street spoke regarding Carter Street and inquired about a city limit sign she said is missing and questioned when was Carter Street annexed into the city limits. Her other concern was reconsideration of developing the Camden Training Center property.

Angel Gonzalez Jr. of Banyard Boykin Road spoke against the development of the Camden Training Center property.

Ordinance 2024-015 2nd Reading

Council, on motion by Councilmember Graham, seconded by Mayor Pro Tem Craig, voted unanimously to approve an ordinance amending certain provisions of the zoning ordinance



of the City of Camden pertaining to the certain uses of property within the R-15 zoning district; and other matters related thereto.

Council/Staff Topics - Councilmember Graham noted Charlotte Water is inviting stakeholders to provide comments on its proposed modification to the existing 2002 interbasin transfer certificate. Charlotte Water is hosting three upcoming public meetings to receive comments, one in which being held at our Revolutionary War Visitor Center tonight June 25th.
